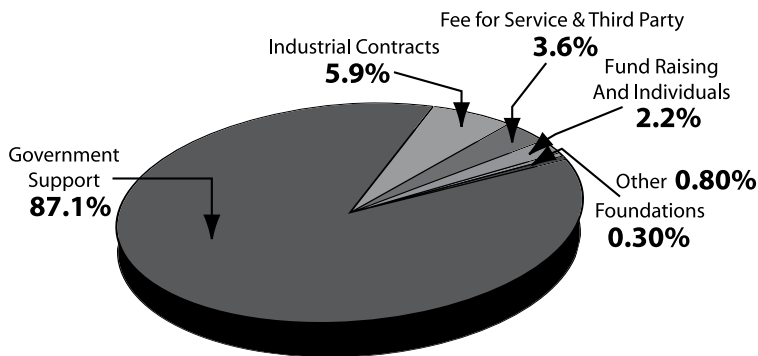

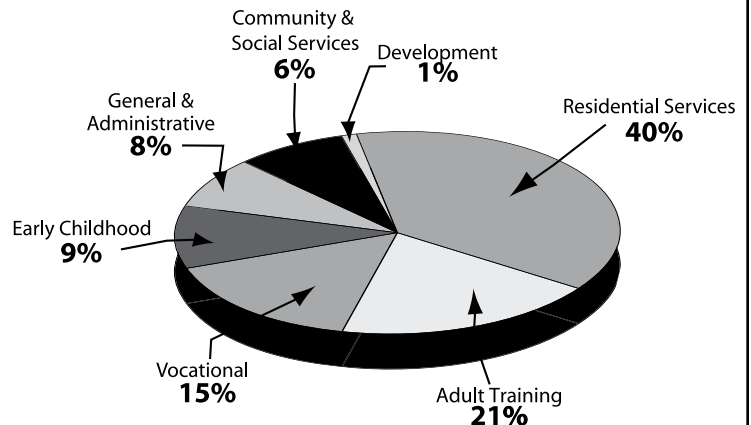
# Financial Summary for Fiscal Year 2012
